FOOD VENDOR GUIDELINES

The Rotary Club of Mariposa Yosemite Art, Wine & Wheels event brings art, wine, food and music together in a beautiful outdoor setting. So that everyone has an enjoyable experience we ask that you review and follow the guidelines below:

1. The EVENT will be held on Saturday, May 27, 2023 from 11:00 AM to 5:00 PM on the Mariposa County Courthouse Lawn. You must be set up by 10:45 AM. Food vendors will be a part of a food court on 10th Street between the Library and Courthouse.
2. Spaces will be assigned by Rotary and you will need to provide your own tables, menu display, chairs, and shade canopy. Tents and canopies must be flame retardant. *You are requested to park additional vehicles at least a block away from the Courthouse during the event to allow for public parking.*
3. The early registration fee for **Food Vendors** is \$50.00 and must be received by May 1, 2023. All entry applications received after May 1, 2023 are \$75 and you will not be included in Festival Brochure. No commission will be charged on your sales. The registration fee is non-refundable.
4. Participants should remember this is an outdoor event and is subject to inclement weather (rain, wind, etc.). The Rotary Club will cancel the event only under extreme weather conditions. The vendor should be aware that the Rotary Club will not accept any responsibility for goods damaged due to inclement weather or any other reason. Vendor must make their own decisions regarding participation. No rain date has been considered.
5. Please complete the attached application form and mail it with your check or money order as soon as possible. Space is limited. You will be confirmed within 30 days of receipt of application and payment. Accepted applicants will receive information by email about ONE WEEK PRIOR TO THE SHOW with booth assignments, maps, parking instructions, and last-minute details.
6. *All food vendors **MUST** provide a copy of their current commercial kitchen license or One-Day Permit from the Health Department to Rotary at least one week prior to the event and have a copy on display to the public on the day of the event.*
7. Food vendors are requested to provide a proposed menu and may be asked to provide a sample of proposed menu items.

AGREEMENT, WAIVER, AND RELEASE

I also understand that the vendor/booth fee is non-refundable. I understand this is an outdoor show and that Rotary will not accept any responsibility for goods damaged due to inclement weather, fire, or other natural disaster. I understand that the vendor must make their own decision to set up or not set up their display. I understand that No refunds will be made for ANY reason.
