You must submit a photograph, or digital photograph for the jury. The photograph(s) must be a good representation of your entry. The photo(s) will not be returned unless you enclose a self-addressed, stamped envelope and a request that they be returned, with your completed application form.
- 3. The chosen art and artist will be featured at the Festival with space, at no cost, for a booth for additional artist's work. See the application for artist booths at www.mariposarotary.org for further information about booth spaces and rules.
- 4. Complete the attached application form and mail (or email) it with your photograph(s) to arrive by the March 15, 2024, deadline. All entrants will receive a response by email or telephone. If you wish, you may submit your entry to srobinson@sti.net.
- 5. The Event Coordinator reserves the right to exclude any vendor for any reason on the day of the event.
- 6. Rotary will credit you as artist in our printed materials.
