We will host a select group of Car Owners who can display their vehicles for the pleasure of the Festival Attendees. So that everyone has an enjoyable experience we ask that you review and follow the guidelines below:

- 1. The event will be held on Saturday, May 25, 2024 from 11:00 AM to 5:00 PM on the Mariposa County Courthouse Lawn. Arrive by 10:30am and see Eric Weihe for assigned parking space.
- 2. Parking spaces will be assigned by Rotary on the south side of the Courthouse. You will need to provide your own tables, chairs, and shade canopy, as necessary for your comfort. Tents and canopies must be flame retardant.
- 3. 1st, 2nd and 3rd Place will be judged during the Festival. Winners will be announced near the end of the Festival.
- 4. Registration is requested by May 1, 2024. Participants should remember this is an outdoor event and is subject to inclement weather (rain, wind, etc.). The Rotary Club will cancel the event <u>only</u> <u>under extreme weather conditions.</u> You should be aware that the Rotary Club will not accept any responsibility for damage due to inclement weather or any other reason. Owners must make their own decisions to participate or not. No rain date has been considered.
- 5. Please complete the attached application form and mail it as soon as possible. Space is limited. You will be confirmed within 30 days of receipt of application. Applicants should receive information by email about ONE WEEK PRIOR TO THE SHOW with parking assignments, maps, parking instructions, and last minute details.
